presented on the action item, which was distributed prior to the meeting. Discussion occurred.
Chair Bulgrin called for a motion. Hurley made the motion to give permission to apply for an EDA
Disaster Grant in an amount TBD, Tiemann seconded. Motion passed unanimously on a vote by

acclamation.

- 2. Action Item York CD-109 Housing Management CDBG Contract: Bliss presented on the action item, which was distributed prior to the meeting. The contract is for \$31,500. Discussion occurred. Chair Bulgrin called for a motion. Moved by Mauk to approve contract, seconded by Glawatz, Hurley abstained. Motion passed with one abstention.
- 3. Action Item City of Pawnee City Kobza Bldg. CDBG Administration Contract: Bliss presented on the action item, which was distributed prior to the meeting. The contract is for \$5,000. Discussion occurred. Chair Bulgrin called for a motion. Moved by Mauk to approve contract, seconded by Glawatz. Motion passed unanimously.
- 4. Action Item City of Pawnee City Kobza Bldg. CDBG Construction Management Contract: Bliss presented on the action item, which was distributed prior to the meeting. The contract is for \$10,000. Discussion occurred. Chair Bulgrin called for a motion. Moved by Mauk to approve contract, seconded by Hurley. Motion passed unanimously.
- 5. Action Item Errors and Omission Insurance Policy: Bliss presented on the action item, which was distributed prior to the meeting. Due to approving the policy mid-year, the cost increases to \$8,122; however, it will cover 18 months. Discussion occurred. Chair Bulgrin called for a motion. Moved by Hurley to budget and purchase Errors and Omission Insurance, seconded by Glawatz. Motion passed unanimously.
- 6. <u>Action Item MLR Dance, LLC Subordination Request</u>: Ertmer presented on the action item, which was distributed during the meeting. Discussion occurred. Chair Bulgrin called for a motion. Moved by Hurley to subordinate the request as presented, seconded by Tiemann. Motion passed unanimously.
- 7. Action Item IRP Loan Review for York County Project: Ertmer presented on the action item, which was distributed during the meeting. A loan in the amount of \$150,000 funded through the Intermediary Relending Program (IRP) Revolving Loan Fund (RLF) to Klute, Inc., which is located in York County. It is a family owned steel fabricator. Discussion occurred regarding terms and interest rate. Chair Bulgrin called for a motion. Tiemann made a motion proposing a 3 percent interest rate and 1 percent servicing fee for 7 years. Motion failed for lack of second. Glawatz made the motion proposing a 2.5 percent for 7 years, seconded by Mauk. Hurley abstained. Motion passed with one abstention.
- 8. <u>Discussion Item Community Development Resources</u>: Bliss presented on a potential project with Community Development Resources. Discussion occurred. No action taken.

- 1. <u>Lancaster County</u>: Bliss offered information on a recent meeting between SENDD and Lancaster County staff.
- 2. CEDS Update: Bliss presented on SENDD's CEDS progress.

- 1. <u>SENDD Health Insurance Plan</u> Bliss reported on SENDD's health insurance plan. The agency's insurance agent initially estimated a 15 percent increase; however, this figure was reduced to 5.62 percent. No action was taken in that the planned increase was budgeted.
- 2. <u>SENAHC Update</u>: Bliss offered an update on SENAHC (Southeast Nebraska Affordable Housing Council). Discussion occurred.
- 3. <u>SEND, Inc. Update</u>: Bliss offered an update on SEND, Inc. Discussion occurred.
